The agreed upon terms were that the invoice is to be paid 100% prior to shipment. We are doing everything we can to get this order expedited to get you a machine as soon as possible and a staggered shipment was agreed upon during a phone call, with no change in the payment terms.

With that being said – I have talked to our accounting department and they are willing to do a one-time change to invoice just this first machine to allow for a first payment of \$34,667.25.
